- 4. Other supporting documents related to the application (e.g. Referral letter from Social Welfare Department or Non-government organizations).

#### 備註:

- 1. 2-3 人家庭必須與青年同住 3 房單位,租住年期為兩年,滿約後必須遷出。
- 2. 申請家庭必須輪候公屋3年或以上。
- 3. 家庭面見評估家庭需要,以作甄選。申請者必須出席面見,其他家庭成員盡量出席。
- 4. 18 歲或以上家庭成員必須簽署查核資料授權書。
- 5. 因疫情考慮,本中心提供親身面見外,亦可安排視像面見供申請者選擇。

### Remarks:

- 1. 2-3 family household and youth will be co-living in a 3 rooms unit in this particular project in 2 years term.
- 2. Applicants should be queuing for Public Rental Housing (PRH) for no less than 3 years.
- 3. Vetting interview is arranged for further understand of the family situation and needs. Applicant must attend the vetting interview, other family members are encouraged to attend.
- 4. Family members aged 18 or above are required to fill and sign the Authorization Letter.
- 5. In consideration of the COVID-19 outbreak, applicants can attend the vetting interview in person or via Zoom or video call.
